ORDER

A hearing in the above-styled matter was held on Thursday, March 31, 2022, at 9 a.m. Eastern Daylight Time. At the conclusion of the witness testimony, staff counsel requested to file post-hearing data requests and Kentucky Broadband and Cable Association (KBCA) requested to file a post-hearing brief after responses to data requests had been filed.

IT IS THEREFORE ORDERED that:

1. Post-hearing data requests, if any, shall be filed on or before March 31, 2022.
2. Responses to post-hearing data requests shall be filed on or before April 7, 2022.
3. KBCA may file a memorandum brief in support of its post-hearing position on or before April 11, 2022.


