ORDER

This matter arises from the Integrated Resource Plan (IRP) of Louisville Gas and Electric Company and Kentucky Utilities Company (LG&E/KU) filed October 19, 2021, pursuant to 807 KAR 5:058. On November 12, 2021, the Commission entered a procedural scheduled that, among other things, established deadlines for any motions to intervene, initial and supplemental requests for information to LG&E/KU, and written comments from intervenors. On April 13, 2022, the Commission modified the procedural schedule to extend the deadline by which intervenors must file written comments and to allow LG&E/KU to file written comments in response to intervenor comments before any other procedural event.

LG&E/KU has now responded to initial and supplemental requests for information from Commission Staff and intervenors, multiple intervenors have filed detailed written comments regarding LG&E/KU's IRP, and LG&E/KU filed detailed comments in response to intervenor comments. Having reviewed the record and being otherwise sufficiently advised, the Commission finds that a hearing should be scheduled in this matter for the purpose of examining witnesses that responded to requests for information to obtain additional information and clarity regarding the IRP.

IT IS THEREFORE ORDERED that:

- A hearing in this matter shall be held on Tuesday, July 12, 2022, at 9 a.m.
 Eastern Daylight Time, in the Richard Raff Hearing Room at the offices of the Public
 Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
- 2. Any witness who responded to a request for information in this matter shall attend the hearing for cross-examination, unless otherwise excused or permitted to attend virtually by a subsequent order.
- 3. LG&E/KU shall give notice of the hearing in compliance with 807 KAR 5:001, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov"; and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, psc.ky.gov." At the time the notice is mailed or publication is requested, LG&E/KU shall forward a duplicate of the notice and request to the Commission.
- 4. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.
