ORDER

On December 20, 2021, Western Fleming County Water District (Western Fleming District) filed a letter requesting an extension of time to file its responses to Commission Staff's First Request for Information. In accordance with the procedural schedule entered on December 3, 2021, the responses were due on December 20, 2021.

As a basis for the request Western Fleming District explained that it needed extra time to respond because there was staff turnover in the office manager position that left it without the resources to respond by December 20, 2021. Western Fleming District requested until January 20, 2022 to file the responses.

The Commission finds that Western Fleming District established good cause to grant the extension of time in order to develop a robust record, therefore the request is granted. However, the Commission notes this extension will require an amended procedural schedule. Additionally, the Commission cautions Western Fleming District that any future requests for extensions of time in this matter should be accompanied by a statement indicating that Western Fleming District agrees not to place new rates into effect until a final Order is issued.

IT IS THEREFORE ORDERED that:

1. Western Fleming District's request is granted.

- 2. Western Fleming District's shall file its responses to Commission Staff's First Request for Information on or before January 20, 2022.
- 3. The procedural schedule established on December 3, 2021, is replaced and superseded by the procedural schedule set forth in the Appendix of this Order.
- 4. Should Western Fleming District require additional extensions of time in this proceeding, Western Fleming District shall include in its motion a statement that it will not place new rates into effect until a final Order is issued.
