On February 16, 2022, Kentucky Industrial Utility Customers, Inc. (KIUC) filed a motion requesting attorneys Jody Kyler Cohn and Kurt J. Boehm be permitted to participate virtually at the hearing scheduled for March 1, 2022, through March 3, 2022. Attorney Michael Kurtz will be present in-person at the hearing. As a basis for this request, KIUC noted the risks and restrictions with the ongoing COVID-19 pandemic. KIUC asserted virtual participation of these attorneys would not prejudice the Commission or any other parties.

Based upon the motion and being otherwise sufficiently advised, the Commission finds that KIUC established good cause to grant the motion to allow counsel to participate virtually in the March 1, 2022, through March 3, 2022, hearing in light of the COVID-19 related concerns raised in the motion. The Commission finds that counsel participating virtually shall be in separate rooms on separate devices to promote a higher quality sound and audio for the hearing than if the parties were in the same room using the same device.

IT IS THEREFORE ORDERED that:

1. KIUC's motion for counsel to participate virtually in the March 1, 2022, through March 3, 2022, hearing is granted.

2. KIUC's counsel that appear virtually shall participate from separate rooms and be on separate devices.

3. Commission Staff shall contact participants with instructions for participating remotely.
