## ORDER

On December 10, 2021, the Commission entered a procedural schedule in the matter of Kentucky-American Water Company's (Kentucky-American) alternative rate filing. Kentucky-American has submitted information in response to two requests for information from Commission Staff and the Attorney General's Office. On February 28, 2022, Kentucky-American filed a motion to file Supplemental Testimony due to an error in the billing determinants and rate design found in the original filed application. In order to adequately review new information presented in Kentucky-American's responses, it is necessary to amend the procedural schedule to issue a supplemental request for information and for the production of the Staff Report.

The Commission, on its own motion, HEREBY ORDERS that the procedural schedule contained in the Appendix to the December 10, 2021 Order is amended as follows:

- 1. All supplemental requests for information to Kentucky-American shall be filed no later than March 14, 2022.
- 2. Kentucky-American shall file responses to supplemental requests for information no later than March 28, 2022.

3. A written report containing Staff's findings and recommendations shall be filed with the Commission on or before April 25, 2022.

4. All provisions of the Commission's Order of December 10, 2021, in conflict with the provisions of this Order are vacated. All other provisions of the Order of December 10, 2021, shall remain in effect.
