Before the hearing date, Mr. Cook shall conduct a test of technology with Commission Staff to ensure that counsel's audio and video capabilities are sufficient.

IT IS THEREFORE ORDERED that:

1. The Attorney General's motion for Lawrence W. Cook to participate virtually in the March 28–March 29, 2022 hearing is granted.

2. Commission Staff shall contact participants with instructions for conducting a test of technology and participating remotely in the hearing.
