ORDER

On March 14, 2022, the LS Power Development, LLC (LS Power), filed a motion requesting Commission approval for its witness, Thomas Hoatson, to participate virtually in the March 28–29, 2022 hearing due to continued risks associated with COVID-19. LS Power noted that Mr. Hoatson would be available to participate in a prehearing dry run to ensure there are no audio or video issues ahead of the hearing. LS Power stated that counsel for LS Power will participate at the hearing in person.

Based upon the motion and being otherwise sufficiently advised, the Commission finds that LS Power established good cause to grant the motion for Mr. Hoatson to participate virtually in the March 28–29, 2022 hearing. Before the hearing date, Mr. Hoatson shall conduct a test of technology with Commission Staff to ensure that counsel’s audio and video capabilities are sufficient.

IT IS THEREFORE ORDERED that:

1. LS Power’s motion for Thomas Hoatson to participate virtually in the March 28–March 29, 2022 hearing is granted.

2. Commission Staff shall contact participants with instructions for conducting a test of technology and participating remotely in the hearing.
