<u>ORDER</u>

On March 30, 2022, the Commission issued an Order suspending the proposed removal of the Subdistrict B surcharge from its tariff. The Order included a procedural schedule.

On its own motion, Commission finds that the procedural schedule should be amended. Therefore, the March 30, 2022 procedural schedule is amended, and the procedural schedule attached as an Appendix to this Order is adopted.

IT IS THEREFORE ORDERED that:

- 1. The March 30, 2022 procedural schedule is amended, and the procedural schedule as set forth in the Appendix to this Order shall be followed.
- 2. The deadline for intervention of additional parties under the March 30, 2022 procedural schedule has passed and shall not be extended.
- 3. Any party filing a paper with the Commission shall file an electronic copy in accordance with the electronic filing procedures set forth in 807 KAR 5:001, Section 8. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked. The Commission directs the parties to the

Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission.

- 4. Boone County Water District (Boone District) shall give notice of any scheduled hearing in accordance with the provisions set forth in 807 KAR 5:001, Section 9(2). In addition, the notice of hearing shall include the following statement: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov"; and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listing on the PSC website, psc.ky.gov." At the time publication is requested, Boone District shall forward a duplicate of the notice and request to the Commission.
- 5. At any public hearing in this matter, neither opening statements nor summarization of direct testimonies shall be permitted.
- 6. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video recording shall be made of the hearing.
- 7. The Commission does not look favorably upon motions for continuance. Accordingly, motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
- 8. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
