### ORDER

On March 31, 2022, Sharpsburg Water District (Sharpsburg District) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure set forth in KRS 278.015 and 807 KAR 5:068.

## LEGAL STANDARD

In accordance with KRS 278.015, when a wholesale supplier selling water to a water district increases its rates, the water district has the authority to increase its rates commensurate with the wholesale supplier. The water district must file a copy of the notice from the wholesale supplier showing the increase in the wholesale rate, and a statement of the volume of purchased water used to calculate the rate adjustment. The Commission shall approve the filing by order after the above documents are filed.

### <u>DISCUSSION</u>

#### Unaccounted-for Water

Commission regulation 807 KAR 5:066, Section 6(3), states that for ratemaking purposes a utility's unaccounted-for water loss shall not exceed 15 percent of the total water produced and purchased, excluding water consumed by a utility in its own operations. In its 2020 Annual Report filed with the Commission, Sharpsburg District

reported a water loss of 19.4660 percent.<sup>1</sup> Sharpsburg District's application provides updated purchase and sales information for a more current period than the 2020 Annual Report. Based upon the updated information in the application and the percentage of other water consumed by the utility in its 2020 Annual Report, Sharpsburg District's unaccounted-for water loss is 22.5450 percent for the updated period.<sup>2</sup> Reduction of Sharpsburg District's unaccounted-for water loss to 15 percent would result in an approximate \$29,202.04 decrease to purchased water expense.<sup>3</sup> Potentially, Sharpsburg District is paying approximately \$0.35 per 1,000 gallons sold for expenses associated with unaccounted-for water loss in excess of the 15 percent threshold.<sup>4</sup> Sharpsburg District's total water loss expense is \$87,257.78.<sup>5</sup>

The Commission is placing greater emphasis on monitoring utilities that consistently exceed the 15 percent unaccounted-for water loss threshold. The Commission strongly encourages Sharpsburg District to pursue reasonable actions to reduce its unaccounted-for water loss. Failure by Sharpsburg District to make significant

progress towards reducing unaccounted-for water loss may cause the Commission to pursue additional action with the utility.

## Financial Condition and Rates

Based on a review of Commission records, Sharpsburg District has not sought a general base rate adjustment since 2010. In Case No. 2021-00189, the Commission ordered Sharpsburg District to file an application for a traditional adjustment in rates or an alternative rate adjustment by May 27, 2022.<sup>6</sup>

In Case No. 2019-00041, the Commission discussed the problems that can occur when utilities intentionally avoid a review of their financial records by relying solely on financing cases to increase rates.<sup>7</sup> A key recommendation from that proceeding was that water districts should monitor the sufficiency of their base rates closely and, in general, apply for base rate adjustments on a more frequent basis.<sup>8</sup>

As documented in annual and audit reports filed with the Commission, Sharpsburg District reported a negative net income for the past six years,<sup>9</sup> which indicates that cash needs may have been supplemented by depreciation reserves as discussed in Case No.

Due to Sharpsburg's continued net operating losses into the calendar year 2020 the Commission finds that Sharpsburg District shall comply with the May 27, 2021 Order in Case No. 2021-00189 by filing, on or before May 27, 2022, an application for a general base rate adjustment or an alternative rate adjustment to ensure that its revenue is sufficient to support adequate and reliable service, or, in the alternative, on or before May 27, 2022, Sharpsburg District may file a formal motion with a detailed analysis of its rates and revenues and a statement of the reasons why a rate case is not necessary. Any filing for a rate adjustment under KRS 278.023 does not relieve Sharpsburg District from this requirement.

## **FINDINGS**

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that:

 Sharpsburg District purchases water from Bath County Water District (Bath District) and the city of Carlisle (Carlisle).

- 2. Carlisle notified Sharpsburg District that its wholesale rate would increase by 33 percent across the board, effective September 30, 2021. On October 20, 2021, an investigation into the reasonableness of Carlisle's proposed wholesale rates was initiated by the Commission and Carlisle's proposed rates were suspended for five months up to March 30, 2022.<sup>11</sup> On March 29, 2022, the Commission approved Carlisle's proposed rates.<sup>12</sup> Sharpsburg District proposes to increase the water rates to its customers effective March 29, 2022, to reflect the increased cost of purchased water from Carlisle.
- 3. Sharpsburg District proposed a purchased water adjustment factor of \$0.14 per 1,000 gallons in its application.
- 4. During the 12 months ended February 28, 2022, Sharpsburg District purchased 88,361,000 gallons of water from Bath District and 21,611,000 gallons of water from Carlisle. During the same period, Sharpsburg District sold 83,463,300 gallons of water. The increase in the cost of purchased water is \$10,940.98, resulting in a purchased water adjustment factor of \$0.14 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.14 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just and reasonable and shall be approved, because the water adjustment factor is supported by evidence of the increase in rates from Sharpsburg District's wholesale water supplier and the volume of purchased water used to calculate the rates in accordance with KRS 278.015.
  - 6. Sharpsburg District's proposed rates are approved.

- 7. The rates as set forth in Appendix B to this Order are fair, just and reasonable and shall be approved for water service rendered by Sharpsburg District on and after March 29, 2022, because the rates are supported by evidence of the increase in rates from Sharpsburg District's wholesale water supplier and the volume of purchased water used to calculate the rates in accordance with KRS 278.015.
- 8. On or before May 27, 2022, Sharpsburg shall file an application for a general rate adjustment pursuant to 807 KAR 5:001, Section 16, or an application for an alternative rate adjustment pursuant to 807 KAR 5:076, or in the alternative, file a formal motion with a detailed analysis of its rates and revenues explaining the reasons why no modifications are necessary.

#### IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.14 per 1,000 gallons is approved.
  - 2. The rates proposed by Sharpsburg District are approved.
- 3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Sharpsburg District on and after March 29, 2022.
- 4. Within 20 days of the date of entry of this Order, Sharpsburg District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
- 5. On or before May 27, 2022, Sharpsburg shall file an application for a general rate adjustment pursuant to 807 KAR 5:001, Section 16, or an application for an alternative rate adjustment pursuant to 807 KAR 5:076, or in the alternative, file a formal motion with a detailed analysis of its rates and revenues explaining the reasons why no

modifications	are necessary. Any filing for a rate adjustment under KRS 278.023 does
not relieve Sh	narpsburg District from this requirement.
6.	This case is closed and removed from the Commission's docket.
