ORDER

Pursuant to KRS 278.712(1), the Siting Board, on its own motion, finds that a local public hearing shall be scheduled in this matter on January 25, 2023, at 5 p.m. Central Standard Time.

KRS 278.712(1) states, "[t]he [Siting] board may convene a local public hearing upon receipt of a request by not less than three (3) interested persons that reside in a county . . . in which the facility is proposed to be constructed." Siting Board regulation 807 KAR 5:110, Section 8(2), requires that the requests for a local public hearing be made in writing no later than 30 days after a completed application is filed.

On October 12, 2023, Thoroughbred Solar, LLC (Thoroughbred Solar) filed an application requesting a Certificate of Construction for a merchant solar generating facility and related transmission line in Hart County, Kentucky. Subsequent to the application being filed, the Siting Board timely received three requests for a local public hearing from residents of Hart County.

Based upon the timely requests received from three Hart County residents, the Siting Board finds that a local public hearing shall be scheduled on January 25, 2023, at 5 p.m. Central Standard Time, at the Hart County Courthouse, 200 Main Street, Munfordville, Kentucky 42765. Thoroughbred Solar shall give public notice of the local public hearing as required in 807 KAR 5:110, Section 9(2). Thoroughbred Solar shall submit proof to the Siting Board of such notice at least three days prior to the January 25, 2023, local public hearing.

Siting Board regulation 807 KAR 5:110, Section 8(3)(b), requires that the Siting Board provide notice of the local public hearing to the Hart County Judge Executive at least 14 days prior to the hearing date. The Siting Board finds that a copy of this Order shall be served upon Hart County Judge Executive Joe Choate.

IT IS THEREFORE ORDERED that:

- A local public hearing in this matter is scheduled for January 25, 2023, at
 p.m. Central Standard Time, at Hart County Courthouse, 200 Main Street, Munfordville,
 Kentucky 42765.
- 2. Thoroughbred Solar shall give timely notice of this local public hearing in a newspaper of general circulation in Hart County as required by 807 KAR 5:110, Section 9(2).
- 3. Thoroughbred Solar shall submit proof to the Siting Board of the notice to the public at least three days prior to the January 25, 2023 hearing.
