### <u>ORDER</u>

On July 28, 2022, Wood Creek Water District (Wood Creek District) filed a motion requesting an extension of time (motion) until August 15, 2022, to submit its responses to Commission Staff's First Request for Information (Staff's First Request) dated July 8, 2022. Pursuant to Staff's First Request issued by the Commission on July 8, 2022, Wood Creek District was to file responses to Staff's First Request with the Commission on August 1, 2022.

In its motion, Wood Creek District pointed to the extensive nature of Staff's First Request, its small staff and limited resources, and its inexperience with discovery requests in general rate cases, and stated that, while it has compiled information and answers to approximately 20 to 25 percent of the requests, it will not be able to file a complete response by the deadline of August 1, 2022.

The Commission, having considered Wood Creek District's motion, finds that good cause exists to grant an extension until August 15, 2022, to file its responses to Staff's First Request dated July 8, 2022. The Commission also finds that the procedural schedule should be amended to allow Commission Staff commensurate time until August 29, 2022, to issue all Initial Requests for Information to Wood Creek District; until

September 12, 2022, for Wood Creek District to file responses to all initial requests for information; until September 26, 2022, for Commission Staff to file all supplemental requests for information; and until October 10, 2022, for Wood Creek District to file responses to all supplemental requests for information. There are no intervenors in this matter and no other dates from the procedural schedule attached as an Appendix to the Commission's July 8, 2022 Order shall be amended at this time

### IT IS THEREFORE ORDERED:

1. Wood Creek District's July 28, 2022 motion for an extension of time is granted.

2. The amended procedural schedule attached to this Order as Appendix A shall reflect the new procedural schedule in accordance with the original July 8, 2022 Order.

3. All provisions of the Commission's Order of July 8, 2022, in conflict with the provisions of this Order are vacated. All other provisions of the Order of July 8, 2022, shall remain in effect.
