On December 12, 2022, Green River Valley Water District (Green River Valley District) filed a motion to reschedule the hearing set for December 15, 2022. Green River Valley District stated that the Chairman of the Board of Commissioners, John Bunnell, was unavailable due to a medical issue.¹ Green River Valley District requested a date in January 2023.²

Having considered the motion, the Commission finds that Green River Valley District has established good cause for a continuance in this matter.

IT IS HEREBY ORDERED that:

1. The motion to continue the hearing is granted.

2. A hearing in this matter shall be held on January 4, 2023, at 9 a.m. Eastern Standard Time, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky. Pursuant to 807 KAR 5:001,

Section 2, if the hearing is not concluded on the designated day, the hearing shall be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.

3. Witnesses who sponsor schedules, testimony, or responses to data requests shall participate in person at any hearing scheduled in this matter.

4. Green River Valley District shall give notice of the hearing in compliance with 807 KAR 5:001, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov"; and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, psc.ky.gov." At the time the notice is mailed or publication is requested, Green River Valley District shall forward a duplicate of the notice and request to the Commission.

5. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.

If any changes are to be made to the witness list filed on November 28,
2022, Green River Valley District shall notify the Commission at least five days prior to the hearing.
