COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION TO EAST KENTUCKY MIDSTREAM, LLC

East Kentucky Midstream, LLC (East Kentucky Midstream), pursuant to 807 KAR 5:001, is to file with the Commission an electronic version of the following information. The information requested is due on October 19, 2022. The Commission directs East Kentucky Midstream to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the

person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

East Kentucky Midstream shall make timely amendment to any prior response if East Kentucky Midstream obtains information that indicates the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which East Kentucky Midstream fails or refuses to furnish all or part of the requested information, East Kentucky Midstream shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, East Kentucky Midstream shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

- 1. Refer to East Kentucky Midstream's response to Commission Staff's First Request for Information (Staff's First Request), Item 1. Provide an additional diagram of the entire natural gas system under East Kentucky Midstream's control, that includes and identifies:
 - a. Any and all suppliers;
 - b. Any and all sales of purchase points;

- c. Any and all customers, residential or commercial, whether free, farm tap, or other.
- 2. Refer to East Kentucky Midstream's response to Staff's First Request, Item 5, Commission Staff considers this as unresponsive. Provide a list of any and all gas lines that had gas flowing at the time of acquisition of Jefferson Gas² by East Kentucky Midstream, but now do not, and include a detailed reason for the stop of flow. This includes, but is not limited to, lines that have been terminated, abandoned, and disconnected. This shall be an ongoing request.
- 3. Refer to East Kentucky Midstream's response to Staff's First Request, Item 1. Provide a diagram and identify all lines currently owned or operated by East Kentucky Midstream that were acquired from Jefferson Gas.
- 4. Identify any alteration to the operation of the lines acquired from Jefferson Gas since acquisition including, but not limited to:
 - Replacement of any section of line;
 - b. Additional customers added;
 - c. Customers that were receiving gas no longer receiving gas;
 - d. Additional purchase point;
 - e. Removed purchase point;
 - f. Additional connection;
 - g. Extension of any line;
 - h. Removal of any line

- i. Installation, movement, replacement or removal of a valve;
- j. Different provider of gas through any line.
- 5. Refer to East Kentucky Midstream's response to Staff's First Request, Item 1. For all lines other than identified in Item 3 listed above, identify how East Kentucky Midstream acquired the lines. Indicate if they were installed by East Kentucky Midstream (or a contractor employed by East Kentucky Midstream) or another party, and if by another party, identify that party.
- 6. Refer to East Kentucky Midstream's response to Staff's First Request, Item 6. Identify and explain the basis for the idling of the 15-mile section of Line A-5.
- 7. Refer to East Kentucky Midstream's response to Staff's First Request, Item 7, Commission Staff considers this as unresponsive. Provide information regarding the limited jurisdiction certificate issued by Federal Energy Regulatory Commission (FERC) to Jefferson Gas in 2009, and whether the certificate has been transferred to East Kentucky Midstream since acquisition, or if the line has been abandoned.
- 8. Refer to East Kentucky Midstream's response to Staff's First Request, Item 7. If the certificate has not been transferred since the acquisition of Jefferson Gas, provide a detailed explanation as to why this has not occurred.
- 9. Explain whether East Kentucky Midstream is still providing transportation on behalf of Columbia Gas Transmission (TCO) to Delta and West Liberty through the KZW line.
- 10. Refer to East Kentucky Midstream's response to Staff's First Request, Item 8, Commission Staff considers this as unresponsive. Provide information regarding the adoption of Jefferson Gas's tariff since acquisition. State whether East Kentucky

Midstream has adopted Jefferson Gas's tariff. If so, state whether East Kentucky Midstream completed all legal requirements in order to adopt the tariff.

Refer to East Kentucky Midstream's response to Attorney General's First

Request for Information (Attorney General's First Request), Item 7, Commission Staff

considers this unresponsive. If other pipelines are available to serve the former

customers of Public Gas who are now served by Kentucky Frontier, identify those

pipelines and the ownership of those pipelines.

12. Refer to East Kentucky Midstream's response to Attorney General's First

Request, Item 12. Identify any and all pipelines classified as non-jurisdictional or

unregulated gathering in the East Kentucky Midstream system. Identify the state or

federal regulatory body that exercises oversight for safety of the non-jurisdictional or

unregulated gathering line.
