ORDER

A hearing in the above-styled matter was held at the office of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky, on Wednesday, January 11, 2023, 9 a.m. Eastern Standard Time. At the conclusion of the witness testimony, staff counsel requested to file post-hearing data requests, and counsel for North Manchester Water Association (North Manchester Water) requested to file a post-hearing brief after responses to requests for information have been filed.

From the bench, the Commission ruled on North Manchester Water's two prehearing motions. The January 6, 2023 motion requested the Commission allow a deviation from the notice requirement in 807 KAR 5:001E, Section 9(2)(b)(2). North Manchester Water stated when *The Manchester Enterprise* published the notice of the hearing the date for the hearing was incorrectly listed as January 11, 2022, instead of January 11, 2023. The January 9, 2023 motion requested North Manchester Water witness Rose Lewis be permitted to testify virtually. The Commission finds good cause exists to grant North Manchester Water's motions. The public was not denied adequate

notice of the hearing because of the incorrect year listed in the published notice.

Additionally, Ms. Lewis' virtually testimony would not prejudice any party or the Commission.

IT IS THEREFORE ORDERED that:

- 1. North Manchester Water's January 6, 2023 motion for deviation from the notice requirements is granted.
- 2. North Manchester Water's January 9, 2023 motion for Rose Lewis to testify virtually is granted.
- 3. Post-hearing data requests, if any, shall be filed on or before January 18, 2023.
- 4. Responses to post-hearing data requests shall be filed on or before February 8, 2023.
- 5. North Manchester Water may file a memorandum brief in support of its posthearing position on or before February 18, 2023.
