ORDER

On January 30, 2023, the Commission issued an Order in this matter approving a rate increase that contained inadvertent errors in the Appendix to the Order.

The last rate step in the 5/8 x 3/4-Inch Meter, 1-Inch Meter, 1 1/2-Inch Meter, 2-Inch Meter, and 3-Inch Meter categories was incorrectly listed as Over 75,500 Gallons, but should have been listed as Over 75,000 Gallons for each respective category. The amended rates were also incorrectly listed as “Per 1,000 Gallons”, when they should have been listed as “Per Gallon” for the rate steps in all meter size categories of the Appendix.


Finding that the January 30, 2023 Order shall be amended, the Commission
HEREBY ORDERS, *nunc pro tunc*, that:

1. The Appendix to the January 30, 2023 Order is stricken and replaced with the Appendix attached to this Order.
2. Within 20 days of the date of service of this Order, Wood Creek Water District shall file with the Commission, using the Commission’s electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.


3. All other provisions of the Commission's January 30, 2023 Order that are not in conflict with the provisions of this Order shall remain in effect.
