ORDER

On September 30, 2022, East Kentucky Power Cooperative, Inc. (EKPC) filed a motion, pursuant to 807 KAR 5:001E, Section 13, and KRS 61.878, requesting that the Commission grant confidential treatment for ten years for redactions from documents it filed in response to Commission Staff's First Requests for Information (Staff's First Request), Items 4, 11, and 29.

The Commission is a public agency subject to Kentucky's Open Records Act, which requires that all public records "be open for inspection by any person, except as otherwise provided by KRS 61.870 to 61.884."<sup>1</sup> In support of its petitions, EKPC argued for the application of KRS 61.878(1)(c)(1), which exempts from disclosure "[r]ecords confidentially disclosed to an agency or required by an agency to be disclosed to it, generally recognized as confidential or proprietary, which if openly disclosed would permit an unfair commercial advantage to competitors of the entity that disclosed the records." Exceptions to the free and open examination of public records contained in KRS 61.878

should be strictly construed.<sup>2</sup> The party requesting that materials be treated confidentially has the burden of establishing that one of the exceptions is applicable.<sup>3</sup>

EKPC's response to Staff's First Request, Item 4 consists of redacted, non-selected coal bid data. The response to Item 11 included EKPC's fuel procurement manual, filed confidentially in its entirety. EKPC's response to Item 29 consists of generation unit data including PJM Interconnection, LLC (PJM) bid status and prices. EKPC argued that this information consists of internal planning information and is commercially sensitive.

Having considered the motion and the material at issue, the Commission finds that EKPC's motion should be granted. Disclosure of coal solicitation information and policies could affect future bidding, allowing competitors to gain an unfair advantage by having access to EKPC's solicitation strategies and bids. This type of information was previously held confidential by the Commission.<sup>4</sup> In addition, generation unit information could be used by competitors to their advantage in the PJM energy market.<sup>5</sup> The Commission finds that the designated materials are records that meet the criteria for confidential treatment and are exempted from public disclosure for ten years pursuant to KRS 61.878(1)(c)(1) and 807 KAR 5:001E, Section 13.

IT IS THEREFORE ORDERED that:

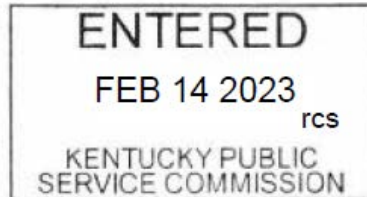
1. EKPC's motion for confidential treatment is granted.
2. The designated material granted confidential treatment by this Order shall not be placed in the public record or made available for public inspection for ten years or until further Order of this Commission.
3. Use of the designated material granted confidential treatment by this Order in any Commission proceeding shall comply with 807 KAR 5:001, Section 13(9).
4. EKPC shall inform the Commission if the designated material granted confidential treatment by this Order becomes publicly available or no longer qualifies for confidential treatment.
5. If a nonparty to this proceeding requests to inspect the material granted confidential treatment by this Order and the period during which the material has been granted confidential treatment has not expired, EKPC shall have 30 days from receipt of written notice of the request to demonstrate that the material still falls within the exclusions from disclosure requirements established in KRS 61.878. If EKPC is unable to make such demonstration, the requested material shall be made available for inspection. Otherwise, the Commission shall deny the request for inspection.
6. The Commission shall not make the requested material available for inspection for 30 days from the date of service of an Order finding that the material no longer qualifies for confidential treatment in order to allow EKPC to seek a remedy afforded by law.
