<u>ORDER</u>

On December 22, 2022, the Commission entered an Order establishing a procedural schedule, which required McKinney Water District (McKinney District) to file its responses to Commission Staff's First Request for Information (Staff's First Request) no later than January 23, 2023.¹ On December 27, 2022, McKinney District's non-attorney consultant, who is assisting McKinney District, submitted a letter to request a 14-day extension until February 6, 2023, to respond to Commission Staff's First Request for Information due to a schedule conflict.² On its own motion, and after having reviewed the record and being otherwise sufficiently advised, the Commission finds that an amended procedural schedule that extends the time for McKinney District to respond to Staff's First Request to February 6, 2023, and makes other necessary adjustments should be established to ensure the orderly review of McKinney District's application.

IT IS THEREFORE ORDERED that:

1. The amended procedural schedule set forth in the Appendix to this Order shall be followed.
