ORDER

On November 14, 2023, Kenergy Corp. (Kenergy) filed a petition, pursuant to 807 KAR 5:001E, Section 13, and KRS 61.878, requesting confidential treatment for certain responses to Attorney General's First Requests for Information (Attorney General's First Request). With this petition, Kenergy filed approximately 37 separate confidential documents, many of which had no label corresponding to a specific item number. On November 20, 2023, Kenergy filed a supplemental response that listed the specific documents for which confidential treatment was sought. Many of the titles of the documents listed did not appropriately correspond to the label of the confidential documents filed. Having considered the petition and the designated material, the Commission directs Kenergy to refile its confidentiality petition and Kenergy shall do the following:

1. In the petition, Kenergy shall address each document for which confidential treatment is requested individually in a discrete paragraph for each document, describing what material is in the document, the statutory basis for the request, and a narrative that identifies the basis for Kenergy's argument that the designated material in each document meets the statutory basis cited by Kenergy.

2. Kenergy shall properly label each confidential document filed corresponding to the appropriate item number and shall ensure that the labels match what is described in the petition.

IT IS THEREFORE ORDERED that Kenergy refile, as set forth in this Order, its petition for confidential treatment for its responses to Attorney General's First Request within 14 days of this Order.
