ORDER


On November 30, 2023, Commission Staff issued their Third Request for Information (Staff's Third Request) to Kenergy Corp. (Kenergy). Staff's Third Request erroneously listed East Kentucky Power Cooperative, Inc. (EKPC) instead of Big Rivers Electric Corporation (BREC) on page 3, question 5(b).

Finding that Staff's Third Request shall be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The reference to East Kentucky Power Cooperative, Inc. (EKPC) on page 3, question 5(b) is stricken and replaced with Big Rivers Electric Corporation (BREC).
2. All other provisions of Staff's Third Request that are not in conflict with the terms of this Order shall remain in effect.
