COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION
TO CELLO PARTNERSHIP D/B/A VERIZON WIRELESS AND TVT II, LLC.

Cello Partnership d/b/a Verizon Wireless and TVT II, LLC (collectively, Joint Applicants), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on May 1, 2024. The Commission directs the Joint Applicants to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a

governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Joint Applicants shall make timely amendment to any prior response if the Joint Applicants obtain information that indicate the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which the Joint Applicants fail or refuse to furnish all or part of the requested information, the Joint Applicants shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, the Joint Applicants shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. For each of the following documents, clarify and explain the inconsistencies on the final height of the proposed lightning arrestor attached at the top of the 255-foot-tall tower. If the differences are the result of an error, does the Joint Applicants anticipate correcting the error? If so, explain. If not, explain why not.

a. The application,² detailed site plan,³ and notice to the Ohio County Judge Executive⁴ of the proposed construction list the height of the lightning arrestor at 11 feet, for a total height of 266 feet.

b. The notice to adjoining property owners⁵ and the legal notice published in the Ohio County Times-News⁶ of the proposed construction lists the height of the lightning arrestor at ten feet, for a total height of 265 feet.

2. Provide a copy of the Kentucky Airport Zoning Commission approval letter.
