ORDER

The Siting Board having issued a show cause Order on January 30, 2026, and Henderson County Solar, LLC (Henderson County Solar) having filed a response on February 19, 2026. Having reviewed the response, the Siting Board, on its own motion finds that an evidentiary hearing should be set. The hearing will be to examine the “transfer approval request” and to further investigate the issues set forth in the January 30, 2026, show cause Order issued by the Siting Board.

The evidentiary hearing scheduled in this matter should be held on March 26, 2026, at 9 a.m. Eastern Daylight Time (EDT) and continue until called from the bench by the presiding officer. If the hearing is not concluded on the designated day, the hearing may be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing. Hearings are held in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky. Witnesses who

sponsor schedules, testimony, or responses to requests for information or Orders are expected to participate in person at a hearing.

IT IS THEREFORE ORDERED that:

1. An evidentiary hearing in this matter shall be held March 26, 2026, at 9 a.m. EDT, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.

2. Henderson County Solar shall file notice of any scheduled hearing with the Siting Board in accordance with the provisions set forth in 807 KAR 5:110, Section 9. In addition, the notice of hearing shall include the following statements: "This hearing will be streamed live and may be viewed on the PSC website, [psc.ky.gov](http://psc.ky.gov)" and "Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listing on the PSC website, [psc.ky.gov](http://psc.ky.gov)."

3. At any evidentiary hearing in this matter, neither opening statements nor summarization of direct testimonies shall be permitted.

4. Any evidentiary hearing scheduled in this matter shall be held on the designated day or days and continued until called from the bench by the presiding officer. If the hearing is not concluded on the designated day, the hearing shall be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.

5. Witnesses who sponsor schedules, testimony, or responses to requests for information shall participate in person at any hearing scheduled in this matter.

6. Pursuant to KRS 278.712(2) and 807 KAR 5:110, Section 6(7), a digital video recording shall be made of the hearing.


