O R D E R

The utility companies operating in Kentucky and subject to the jurisdiction of the Public Service Commission of Kentucky having reported to the Commission their gross receipts derived from intra-state business in Kentucky for the calendar year ended December 31, 1944; and the Commission having determined that its maintenance expense during the fiscal year ending June 30, 1946, will be approximately \$75,000.00, the Commission does hereby apportion among and assess the amount of said expenses upon said utility companies in proportion to their gross earnings or receipts derived from intra-state business in Kentucky for the calendar year ending December 31, 1944, as set forth as follows:
