ORDER

Subject to the jurisdiction of the Public Service Commission of Kentucky, having reported to the Commission their gross receipts derived from intrastate business in Kentucky for the calendar year ended December 31, 1960, and it having been determined that it is necessary to make an assessment in the amount of \$400,000 for the maintenance of the Commission and other necessary expenditures during the fiscal year ending June 30, 1962, the Commission hereby does apportion among and assess the amount of \$400,000 upon the said utility companies.

These amounts so assessed are in proportion to the gross receipts derived from intrastate business in Kentucky for the calendar year ended December 31, 1960, except that the assessment upon any utility is not less than \$5.00, as provided by KRS 278.130.
