O R D E R

On the 2nd day of January, 1974, the Secretary of the Public Service Commission directed a letter to all utilities subject to the Commission's jurisdiction stating that the Annual Report relating to operations ending December 31, 1973, shall be filed with the Commission on or before March 31, 1974. Reference was made to Rule III-I of the Commission's General Rules which sets forth this requirement. Forms were supplied pursuant to the aforementioned Rule.

On the 20th day of May, 1974, the Chairman directed a letter to those utilities which had not submitted the Report. The letter stated that it would be necessary for the Commission to enter a Show Cause Order, issue appropriate subpoenas and schedule a public hearing should the Report not be filed on or before May 31, 1974.
