ORDER

On the 2nd day of January, 1975, the Secretary of the Public Service Commission forwarded two (2) copies of the Report of Gross Operating Revenues derived from intrastate business for the year ended December 31, 1974. Reference was made to Section 278.140 of the Kentucky Revised Statutes which sets forth this requirement. The aforementioned Section states that the Report shall be filed on or before March 31 relating to business for the preceding calendar year. Forms were supplied pursuant to the aforementioned Statute.

On the 11th day of April, 1975, the Chairman of the Commission directed a letter to those utilities which had not complied. It was indicated that should the Report not be received on or before April 25, 1975, it would be necessary to issue subpoenas and to schedule a public hearing.

The following utilities have not filed the Report of Gross Operating Revenues relating to operations for the calendar year 1974 as required by Section 278.140 of the Kentucky Revised Statutes:
