O R D E R

IT IS THEREFORE ORDERED That Phillips' Gas Company, Auxier Water Company, General Land, Mineral and Water Company, K & N Water Service, Lovelaceville Water Company, Rochester Water District, Bahama Gardens Water & Sanitary Sewage Systems, Inc., Caven Village, Inc., Glen Hill Manor Sanitation, Inc., Joseph B. Filiatreau, Realtor, Ni-Cole Construction, Inc., Operle Advertising Company - Cherokee Subdivision, Redwing Utility Company, Inc., Spanish Cove Sanitation, Inc. and Willow Creek, Inc. be and they hereby are ordered and directed to forthwith file with the Commission the 1976 Annual Reports.

IT IS FURTHER ORDERED That Phillips' Gas Company, Auxier Water Company, General Land, Mineral and Water Company, K & N Water Service, Lovelaceville Water Company, Rochester Water District, Bahama Gardens Water & Sanitary Sewage Systems, Inc., Caven Village, Inc., Glen Hill Manor Sanitation, Inc., Joseph B. Filiatreau, Realtor, Ni-Cole Construction, Inc., Operle Advertising Company - Cherokee Subdivision, Redwing Utility Company, Inc., Spanish Cove Sanitation, Inc. and Willow Creek, Inc. shall forfeit and pay to the State Treasurer, to be credited to the General Fund, the sum of \$500 each.

IT IS FURTHER ORDERED That in the event said payment has not been made within ten (10) days from the date of this Order, or, in the alternative, that the required 1976 Annual Report has not been filed within ten (10) days from this date, counsel for the Commission is ordered and directed to proceed against Phillips' Gas Company, Auxier Water Company, General Land, Mineral & Water Company, K & N Water Service, Lovelaceville Water Company, Rochester Water District, Bahama Gardens Water & Sanitary Sewage Systems, Inc., Caven Village, Inc., Glen Hill Manor Sanitation, Inc., Joseph B. Filiatreau, Realtor, Ni-Cole Construction, Inc., Operle Advertising Company - Cherokee Subdivision, Redwing Utility Company, Inc., Spanish Cove Sanitation, Inc. and Willow Creek, Inc. to recover the penalty invoked herein in a proceeding in the Franklin Circuit Court.
