

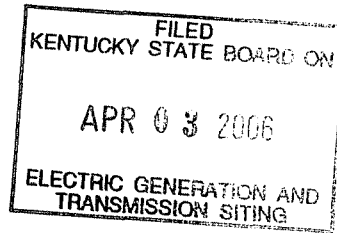

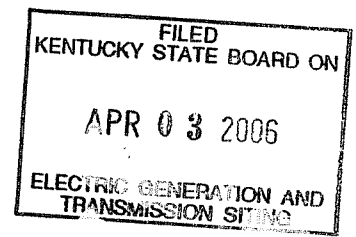

SUPPLEMENT TO NOVEMBER 22, 2005 MOTION TO APPROVE THE THOROUGHbred/BREC IOA

Applicant, Thoroughbred Generating Company, LLC ("Thoroughbred"), Supplements its November 22, 2005 Motion to Approve the Interconnection and Operating Agreement (the "IOA") between Thoroughbred and Big Rivers Electric Corporation ("BREC"). This Supplement serves to clarify the relief requested by Thoroughbred in its original Motion which is incorporated by reference as if fully set forth herein.


The relief requested below is substantially similar to that originally requested. Thoroughbred's Motion and the relief requested only relate to the Thoroughbred/BREC IOA and the relationship between Thoroughbred and BREC as described in the Thoroughbred/BREC IOA. Thoroughbred's Motion does not address, or seek approval for, its relationship with any other entity. Specifically, Thoroughbred's Motion does not address, or seek approval for, any aspect of Thoroughbred's relationship with Intervenor, Louisville Gas & Electric/Kentucky Utilities Company.

Thoroughbred moves the Board, similar to BREC's filing with the Commission, to approve the IOA finding as follows:

- 1. The Thoroughbred/BREC IOA complies with the requirements of KRS 278.212.

2. The Thoroughbred/BREC IOA satisfies Condition K of the Board's December 5, 2003 Order.
3. The Thoroughbred/BREC IOA otherwise complies with the Board's December 5, 2003 Order.
