BellSouth indicated in its May 26, 2005, letter to the Commission that it chooses to continue operating under the Georgia plan, and will adopt in Kentucky any future modifications made to the Georgia plan unless alternatives in other states progress to the point that they should be considered in Kentucky. BellSouth wishes to advise the Commission that on June 6, 2005, BellSouth and certain CLECS jointly moved the Georgia Public Service Commission to approve the BellSouth Service Quality Measurement Plan and Georgia SEEM Administrative Plan ("proposed SQM/SEEM plan"). Upon approval of the proposed plan by the Georgia Commission, BellSouth will file with this Commission the proposed SQM/SEEM plan which will supersede and replace the current SQM/SEEM plan.


