INTERVENORS', IBEW/TRADES COUNCIL, MOTION FOR INFORMAL CONFERENCE

Come the Intervenors, IBEW/Trades Council, by counsel, and move the Commission to hold an informal conference with Commission staff, pursuant to 807 KAR 5:001, Section 4(4). As grounds for the motion, Intervenor Trades Council states that based upon best available information, and belief, the announced decisions of LG&E and EPC contractor Bechtel outline a hiring strategy that predictably will have the result of denying bona fide employment opportunities to the majority of skilled trade craft workers in Kentucky, resulting in the necessity of importing a substantial percentage of out of state workers to perform the job. The strategy being employed by LG&E and the EPC bidder will contravene both the letter and spirit of conditions imposed by the Siting Board in its Order of November 16, 2005. A delay in action, in light of the available information, until the time of annual reports by LG&E pursuant to Siting Board conditions, will result in irreparable injury to the economic interest of Kentucky workers whose opportunities will have been foreclosed for a year.

Intervenors seek an opportunity to disclose its information to Commission staff through an informal conference.

Intervenors seek the informal conference during the week of April 17th or week of April 24th, with preference on April 24th, 25th afternoon, 26th morning or 27th afternoon.
