1. Filing deficiency pursuant to SB 257 Sec 4(2)(b):

A full description of the proposed site, including a map showing the distance of the proposed site from residential neighborhoods, the nearest residential structures, schools, and public and private parks that are located within a two (2) mile radius of the proposed facility.

The statutory time period in which the Board must process this case will not commence until the above-mentioned information is filed with the Commission. You are requested to file 10 copies and one electronic filed copy of this information within 15 days of the date of this letter. If you need further information, please contact A.W.
