To Whom It May Concern:

Attached please find my request for a public hearing regarding Case #2005-00142 Transmission Lines and Case #2005-00152 Generation Plant. It is my understanding that there is a plan for E-ON, a German Owned/Investor Owned Company—parent company of LG&E and Kentucky Utilities, to use my land and the land of my neighbors for a transmission line to run from the Mill Creek Generation Station to the Hardin County Substation for the purpose of selling energy. I am extremely distraught to think that responsible individuals in Kentucky would allow a “take over” of our property. I am not a wealthy individual. In fact, I worked long and hard and sacrificed during my youth in order to purchase property that has been in my family for over 80 years—land that I wanted to enjoy during my retirement. This land is prime farm land and provides me with additional income to add to my retirement, which is among the lowest income level. I now find that individuals from a big business and who certainly have deeper pockets than my neighbors and I want to come and take away the enjoyment and livelihood I might have during my remaining years. I do not know how I will survive without the income I am presently taking in from the farm. I also worked long and hard to purchase this land that has been in our family so that I might pass on to my heirs for livelihood and enjoyment. This attempt by big business to bring in a transmission line that will pollute the air and ruin my land has caused me much mental and physical stress. I have been told that the energy they are selling will not even go to benefit the individuals in the county in which I live. I have also been told that most of the work that will be done to install the line will be contracted out and that individuals in the state of Kentucky will not even benefit from the work needed to be done to install the line. I will be forced to continue to pay property taxes on land that will likely be reduced in value, while a small group of individuals in a big, for-profit business will continue to get rich off mine and my neighbor’s pain. I do not believe this action is for the good of my community or society, but rather I believe it is so a small group of the elite will make money off of my land. I will make nothing and I will have to watch the individuals around me suffer and possibly die if this proposal is allowed to come to fruition.
