Since this is security sensitive information, please abide by the following use constraints:

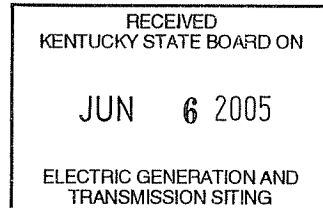
