(b) Please additionally provide the information requested in (a) for each county in which KU operates. If possible, provide this data in the form of an Excel spreadsheet.

(c) Please additionally provide the information requested in (a) for each zip code in which KU operates. If possible, provide this data in the form of an Excel spreadsheet.

(4) (a) How many Kentucky Utilities residential accounts were shut off for non-payment in each year 2007, 2008, 2009, 2010, 2011, and through the most current date available in 2012?

(b) Of the accounts in the answer above, how many of those were shut off more than once for non-payment?

(5) (a) How many Kentucky Utilities residential accounts were shut off for non-payment in each year 2007, 2008, 2009, 2010, 2011, and through the most current date available in 2012 in each county in which KU operates. If possible, provide this data in the form of an Excel spreadsheet.

(b) How many Kentucky Utilities residential accounts were shut off for non-payment in each year 2007, 2008, 2009, 2010, 2011, and through the most current date available in 2012 in each zip code in which KU operates. If possible, provide this data in the form of an Excel spreadsheet.

(6) Please provide the average monthly bill for Kentucky Utilities residential customers (in dollars, not usage) for each year 2007, 2008, 2009, 2010, 2011, and thus far in 2012.
