## MOTION OF ALICE HOWELL, CARL VOGEL, AND SIERRA CLUB TO RESCHEDULE HEARING SET FOR APRIL 21, 2015

On January 30, 2015, the Commission issued an order in the above-captioned general rate case setting the hearing to begin April 21, 2015. The Commission's calendar indicates that this hearing is expected to continue through April 23, 2015. Sierra Club and its member cointervenors (collectively "Movants"), hereby move the Commission to reschedule these hearings.

The expert witness for the Sierra Club, Mr. Jonathan Wallach, has a longstanding commitment the entire week of April 20, 2015 for a previously scheduled and paid-for family vacation. Sierra Club is committed to making its witness available for questioning by the Commission and other parties. In addition, Sierra Club's ability to represent its members' interests will be impaired if its witness is not present throughout the hearing to assist counsel. Therefore, Sierra Club respectfully requests that the Commission postpone the hearing by no more than one week to dates that would allow for our full participation and are convenient for the Commission and other parties.

Sierra Club does not seek to delay this hearing unnecessarily. We recognize that the Commission may request post-hearing briefs and requires ample time to consider the record and render its opinion. Sierra Club's counsel and witness are available the week following the

current hearing date (the week of April 27, 2015), and can discuss with Staff available dates in May if required. Rescheduling this hearing will not prejudice any party, as Sierra Club is seeking a postponement of no more than one week. Sierra Club promptly notified counsel for Louisville Gas & Electric Company and Kentucky Utilities Company of this conflict in an effort to identify convenient alternative dates for a hearing, and is filing this motion as soon as possible to respectfully request the Commission's accommodation.
