**MOTION OF LOUISVILLE GAS AND ELECTRIC COMPANY  
AND KENTUCKY UTILITIES COMPANY FOR AN EXTENSION  
OF TIME IN WHICH TO FILE DATA RESPONSES AND TESTIMONY**

Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") respectfully move the Kentucky Public Service Commission ("Commission") to issue an order granting LG&E and KU through and until August 12, 2015, to file their prepared direct testimony and responses to the information requested in Appendix B to the Commission's Order of July 10, 2015. In support of this motion, LG&E and KU state as follows:

On July 10, 2015, the Commission issued orders establishing procedural schedules in the above-captioned proceedings. In those orders, the Commission instructed LG&E and KU to file their direct testimony and their responses to requested information by July 31, 2015. Additional time is needed for the Companies to provide a complete response to the requested information and to prepare direct testimony due to the current work load and to accommodate the vacation schedules of employees involved in their preparation.

**WHEREFORE,** Louisville Gas and Electric Company and Kentucky Utilities Company respectfully request that the Commission issue an order granting the relief requested herein.
