VERIZON'S REQUEST FOR LEAVE TO SUPPLEMENT THE RECORD WITH CITATIONS

Comes the Intervenor, McImetro Access Transmission Services LLC d/b/a Verizon Access Transmission Services LLC ("Verizon"), and requests leave of the Commission to provide it with time for Verizon to supplement the record herein with citations that are in contrast with or otherwise offer explanation to the cases the Applicant put into this record by a filing dated January 12, 2016. Verizon requests to have up to and including **February 5, 2016** to provide the Commission with citations or other explanations regarding those references recently provided by the Applicant.

Moreover, Verizon's instant request for leave to address the citations is authorized and recognized by 807 KAR 5:001 Section 5(2), as well as Verizon's overarching due process right to have a meaningful opportunity to address issues and arguments raised by the

parties to the matter. *American Beauty Homes Corp. v. Louisville and Jefferson County Planning and Zoning Commission*, 379 S.W.2d 450, 456 (Ky. 1964).

WHEREFORE, this Intervenor requests an opportunity to address the supplemental citations recently offered by the Applicant, which had not been cited (or available) to the parties when the initial briefing was conducted and closed, and to give Verizon leave to supplement the record on or before **February 5, 2016**.
