1. Reference Mr. Ratchford's testimony, page 10. Please produce any studies or evidence developed by or known to CAC that demonstrates that a graduated or tiered rate structure benefits low-income customers.

Response:

CAC is not aware of any study that demonstrates a graduated or tiered rate structure specifically benefits low-income customers more than any other customer, or more than a reduced rate service for low income customers. However, CAC continues to encourage the Commission to order actions that would specifically assist low income customers' ability to pay the increasingly unaffordable rates of Kentucky American Water Company.

2. Reference Mr. Ratchford's testimony generally. Please produce any empirical and/or statistical evidence developed by or known to CAC regarding the household size of low-income customers as compared to household size of all customers.

Response:

Mr. Ratchford's testimony did not discuss or make arguments based on household size of low-income customers. Community Action Council conducts approximately 30,000 intakes annually in Central Kentucky utilizing its Intake Referral and Information System (IRIS). Utilizing data from IRIS, the Council is able to provide the following profile of families served by our organization. The average household size of participants in all Community Action Council programming (all are low-income by various definitions) is as follows according to the Council's fiscal year:

July 1, 2011 – June 30, 2012: 2.28
July 1, 2012 – June 30, 2013: 2.29
July 1, 2013 – June 30, 2014: 2.27
July 1, 2014 – June 30, 2015: 2.20
```

This data reflects a mostly downward trend in household size. The Council does not maintain additional data regarding household size and customers with low-incomes.
