GOVERNMENT'S MOTION FOR DEVIATION**


Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and Lexington-Fayette Urban County Government ("LFUCG") and respectfully requests a deviation from 807 KAR 5:001 Sections 8(3) and 12(a), which requires a paper copy of electronically filed documents to be filed with the Commission, and from the Commission's Procedural Order dated February 22, 2016, numerical paragraph 3(a) requiring an original in paper medium of Responses to Requests for Information to be filed with the Commission.

The Attorney General and LFUCG electronically filed the Responses to the Commission and Kentucky-American Water's Request for Information on June 6, 2016, and intends to file the Responses in paper medium on June 8, 2016, with the exception of the Woolridge Articles Volumes 1-7 ("Articles"). The Attorney General and LFUCG are requesting deviation from filing the Articles in paper medium since it contains over 5,000 pages that would require excessive time, money, and paper to print, tab, and compile this portion of the filing. The remainder of the Attorney General and LFUCG's Responses to Requests for Information shall be filed in accordance with the rules and in conformity with the Commission's Procedural Order.

WHEREFORE, the Attorney General and LFUCG respectfully request that the Commission grant the motion for deviation as to the Woolridge Articles Volumes 1-7.




