NOTICE is hereby given that the Kentucky Public Service Commission has scheduled a public hearing in a case styled “In the Matter of Application of Duke Energy Kentucky, Inc. for (1) A Certificate of Public Convenience and Necessity Authorizing the Construction of an Advanced metering Infrastructure; (2) Request for Accounting Treatment; and (3) All Other Necessary Waivers, Approval, and Relief,” Case No. 2016-00152, beginning Thursday, December 1, 2016, at 9:00 a.m. Eastern Daylight Time, at the Commission’s offices, 211 Sower Boulevard, Frankfort, Kentucky for approval to replace and upgrade its existing metering infrastructure by constructing and installing a more advanced system of digital technologies including Advanced Metering Infrastructure for its electric and combination electric and natural gas operations and an Automated Meter Reading infrastructure for its gas only operations.
