MOTION TO CONVERT THE ABOVE-STYLED CASE FROM AN ELECTRONIC FILING PROCEDURE CASE TO A TRADITIONAL FILING PROCEDURE CASE

Comes now Farmers Rural Electric Cooperative Corporation ("Farmers RECC"), by counsel, and hereby moves the Kentucky Public Service Commission ("Commission") to convert the above-styled case from an electronic filing procedure case, (807 KAR 5:001 Section 8), to a traditional filing procedure case, (807 KAR 5:001 Section 7) and to amend the case style accordingly. As grounds for said motion, Farmers RECC respectfully states as follows:

On October 14, 2016, Farmers RECC filed a notice of intent to file a rate case and an election to use the electronic filing procedures set forth in 807 KAR 5:001 Section 8, which provides for an electronic version to be filed using the Commission's E-Filing System and one paper copy to be filed with the Commission. On that same day, the Commission issued an Order stating "Any party filing a paper shall upload an electronic version using the Commission's E-Filing System and shall file an original and six copies in paper medium...."

Complying with the Commission's Order to file six paper copies along with the electronic copy and the original paper copy will be more expensive and time consuming for Farmers RECC than simply using the traditional paper-based filing procedures established in 807 KAR 5:001 Section 7. Furthermore, the Commission's Order is inconsistent with the electronic filing

procedures set forth in 807 KAR 5:001 Section 8, which were adopted in 2013 to reduce the administrative burden and cost of proceedings on regulated utilities.

WHEREFORE, Farmers RECC respectfully moves the Commission to convert this case from an electronic filing procedures case to a traditional paper-based filing procedures case and to amend the case style accordingly.
