**PETITION OF KENTUCKY CABLE TELECOMMUNICATIONS
ASSOCIATION FOR GUIDANCE ON HEARING**

The Kentucky Cable Telecommunications Association (“KCTA”) respectfully requests further guidance from the Commission on the schedule and nature of the hearing scheduled to begin May 9, 2017, in the above-captioned matter. As noted in Staff’s April 27, 2017, memorandum, the parties have reached a settlement of all issues concerning the pole attachment tariff, and intend to submit a stipulation to that effect shortly. While KCTA understands the hearing is to proceed as scheduled, in light of the pole attachment tariff settlement, the extent to which KCTA and its witnesses and lead counsel will need to be present or participate at hearing is unclear. Accordingly, KCTA requests guidance from the Commission on its plans for the hearing in terms of the timing and consideration of the issues, witness testimony, and participation of counsel. Further guidance is pressing for KCTA given its lead counsel plans to attend and participate in his sister’s wedding in Doolin, Ireland, on May 9th, which, given the nature of such proceedings, is intended to be a once-in-a-lifetime event. Both of KCTA’s witnesses are available for testimony as needed on May 17, 2017.
