

On or around April 28, 2017, Logan Telephone Cooperative, Inc. will file with the KY Public Service Commission an increase in basic local service rates charged to residential subscribers due to a **Federal Communication Commission** mandate. With this change, residential rates are proposed to increase from \$18 to \$20. Business rates are unchanged with this filing. To offset this increase, Logan is eliminating its separate charge for area calling and all customers will enjoy free calling to the areas previously covered by those plans. In addition, calls between any of our six Logan Telephone exchanges will also be free of toll charges. If approved by the PSC, the effective date of this rate change will be May 31, 2017.

The impact of this filing will be based on your calling patterns. [See below for a list of all local calling areas.] For customers that call the new free areas, you may find your savings for toll charges will dramatically reduce the impact of this filing:

This increase is mandated by recent changes enacted by the Federal Communications Commission, which set minimal local service rate levels as a condition of continued receipt of federal high cost support that allows us to deploy fiber optic facilities and support advanced voice and broadband services. Because this support is vital to the economic health of our community, we have no choice but to request this rate increase.

Rates contained in this notice are the rates proposed by the Company, but the Public Service Commission may order rates to be charged that differ from the proposed rates contained in this notice.

You may submit a timely written request for intervention to the Public Service Commission, Post Office Box 615, Frankfort, Kentucky 40602, establishing the grounds for the request including the status and interest of the party. If the Commission does not receive a written request for intervention within thirty (30) days of initial publication or mailing of this notice, the Commission may take final action on the application.
