KCTA's intervention also will allow the interests of KCTA's members to be represented without the burden of each member being required to retain its own counsel, participate individually in the proceedings, and make its own filings. KCTA's participation in this case is likely to present issues and develop facts that will assist the Commission in fully considering the matter.
