

*****NOTICE*** FEBRUARY 1, 2008
TO LIFELINE CUSTOMERS
“CERTIFICATION REQUIRED”**

Each year the FCC and Kentucky Public Service Commission requires Thacker-Grigsby Telephone Company to verify the eligibility of its Lifeline customers.

To be eligible for a Lifeline credit on your phone bill, a customer must be a **current recipient** of any one of the following low income assistance programs.

1. Supplemental Security Income
2. Food Stamps
3. Medicaid
4. Federal public housing/Section 8
5. Low Income Home Energy Assistance Program (LIHEAP)
6. Temporary Assistance to Needy Families Program (TANF)
7. National School Lunch's Free Lunch Program

In order to continue receiving the Lifeline credit on your phone bill, you **must provide Thacker-Grigsby Telephone Company with proof of eligibility within 45 days of this notice.** Proof of eligibility as required by the Kentucky Public Service Commission in any of the qualifying low income programs should be provided to the telephone company by **March 19, 2008.** **If proof of eligibility is not received by the phone company by the due date, you will no longer receive the Lifeline credit on your bill.**

You can obtain proof of eligibility from the low income program in which you qualify. **Please return your proof of eligibility along with your name and phone number in the enclosed self addressed stamped envelope by March 19, 2008.** If you have any questions, please feel free to contact our business office at (606) 785-9500, Monday – Friday, 8:00 a.m. – 4:30 p.m.
