ORDER

On February 3, 1999, William P. Wall ("Complainant") filed a formal complaint against Madison County Utilities District ("Madison County Utilities"). The Complainant alleged that Madison County Utilities had failed to provide water service in a timely manner to the Complainant and other residents of the Doylesville Road area. On February 10, 1999, the Commission ordered Madison County Utilities to satisfy or answer the complaint. On March 29, 1999, Madison County Utilities wrote to the Commission stating that the Complainant had received service on February 4, 1999, and the complaint was thereby resolved to the Complainant's satisfaction. The Commission, being sufficiently advised, HEREBY ORDERS that within 10 days of the date of this Order, the Complainant shall notify the Commission in writing whether he believes the complaint has been resolved. If no response is received by the Commission, this complaint shall be dismissed without further Order.

Please note the sequence of events leading to the arrival of PSC's notice concerning Mr. William Wall's complaint:

- 1. MCUD spent February 1-2, 1999, making corrections and adjustments to the PRV Vault in preparation for activating service to residents of Doylesville area;
- 2. Bacteria samples were collected and submitted to Commonwealth Technology, February 1, 1999;
- 3. MCUD's Field Supervisor spoke with Mr. and Mrs. Wall February 2, 1999, about water service, Bac-T Samples and time required to secure results;
- 4. Received notice from laboratory, the afternoon of Feb. 3, 1999; sample passed;
- 5. Lines flushed again Feb. 4, 1999; Meters for the Walls (3060 Doylesville Road) and others in that area were activated for use;
- 6. Received call from Mrs. Wall on Saturday, Feb. 6, 1999, that meter was leaking; sent service truck to area to correct the problem;
- 7. Monday, Feb. 8, 1999, received PSC Notice (#99-039), dated Feb. 2, 1999.

Mr. and Ms. Wall had been receiving water since Feb. 4, 1999, when the PSC Notice arrived. MCUD failed to respond in a timely fashion, feeling that the problem had been resolved.
