Filing Deficiencies

Dear Sir:

The Commission staff has conducted an initial review of your filing in the above case. This filing is rejected pursuant to 807 KAR 5:001, Section 2, as it is deficient in certain filing requirements. The items listed below are either required to be filed with the application or must be referenced if they are already on file in another case or will be filed at a later date.

Filing deficiencies pursuant to 807 KAR 5:063:

- 1) Section 1(1)(d) A geotechnical investigation report, signed and sealed by a professional engineer registered in Kentucky, that includes boring logs, foundation design recommendations, and a finding as to the proximity of the proposed site to flood hazard areas (findings re: flood hazard area proximity may be prepared by a land surveyor)
- 2) Section 1(1)(e) Clear directions from the county seat to the proposed site, including highway numbers or street names, and the telephone number of the preparer of the directions.



- 3) 1(1)(h) A site development plan or survey, signed and sealed by a professional engineer registered in Kentucky, that shows the proposed location of the tower and all easements and existing structures within 200 feet of the access drive, including the intersection with the public street system.
- 4) Section 1(1)(k) A map drawn to a scale no less than 1 inch equals 200 feet, that identifies every structure and every owner of real estate within 500 feet of the proposed tower.
- 5) Section 1(1)(n) A statement that the local county judge, executive, has been:
 1. Notified by certified mail, return receipt requested, of The proposed construction;
 2. Given the Commission docket number under which the Application will be processed; and
 3. Informed of his right to request intervention.
- 6) Section 1(1)(o) A copy of the notice sent to the county judge executive.
- 7) Section 1(1)(p) A state that two written notices, at least 2' x 4', one in a visible location on the proposed site and one on the nearest public road have been, and shall remain, posted for at least two weeks after the application has been filed.
- 8) Section 1(1)(t) A map of the area in which the tower is proposed to be located, that is drawn to scale and that clearly depicts the search area in which a site should, pursuant to radio frequency requirements, be located.

The statutory time period in which the Commission must process this case will not commence until the above-mentioned information is filed with the Commission. You
