

As you now, KTUC has been involved during the long course of the proceedings in this very complicated case. Our position, well known to the Commission, is that LG&E/KU has made the case that ratepayers will realize very significant savings by withdrawing from MISO and transferring functional control of its transmission system to SSP and TVA as RTO and Reliability Coordinator respectively. In respect of the MISO Application for Rehearing, KIUC will not file a Memorandum In Opposition, but rely upon LG&E/KU to convince the Commission that the Application is not meritorious and should be denied.
