MOTION OF KENTUCKY UTILITIES COMPANY AND LOUISVILLE GAS AND ELECTRIC COMPANY TO SCHEDULE AN INFORMAL CONFERENCE

Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E," collectively, the "Companies") move the Kentucky Public Service Commission ("Commission") to schedule an informal conference in this case. In support of this Motion, the Companies state as follows:

On June 16, 2004, counsel for the Companies circulated an e-mail to counsel for all parties, intervenors and the Commission in this case requesting an informal conference on issues concerning the markets the Midwest Independent Transmission System Operator's ("MISO") Energy Markets Tariff ("EMT") would create, commonly known as MISO's "Day 2 markets." Over the following days Companies' counsel and MISO's counsel had discussions concerning the scope and specificity of the subject matter to be discussed at such a conference. Counsel agreed to participate in such a conference and agreed that July 20, 2004, was a workable date. Companies' counsel has received no response from either of the intervenors indicating that such a conference is objectionable or that July 20, 2004, is an inconvenient date.

WHEREFORE, the Companies move the Commission to enter an order scheduling an informal conference on July 20, 2004.
