RESPONSE OF LOUISVILLE GAS AND ELECTRIC COMPANY AND KENTUCKY UTILITIES COMPANY TO THE MIDWEST INDEPENDENT TRANSMISSION SYSTEM OPERATOR, INC.'S REQUEST FOR PARTIAL EXTENSION OF THE PROCEDURAL SCHEDULE

Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") (collectively, "the Companies") do not object to the Midwest Independent Transmission System Operator, Inc.'s ("MISO") Request for Partial Extension of the Procedural Schedule ("Request for Extension"), filed on October 20, 2004. The Companies condition their lack of objection, however, on MISO's production by e-mail each day, beginning today, of the responses that MISO has prepared to the Companies' Data Requests dated October 6, 2004. This "rolling production" will allow the Companies best to prepare for the informal conference that is scheduled in this case for next Tuesday, October 26, 2004. To that end, the Companies further request that MISO make every reasonable effort to prepare and produce as many of its responses as early as possible.
