NOTICE TO THE COMMISSION

On March 8, 2004, Midwest Independent System Operator, Inc. ("Midwest ISO")

petitioned the Commission pursuant to 807 KAR 5:001 § 7 for an Order granting confidential treatment and protection from public disclosure certain information provided in response to requests by the Commission or its staff at the Commission's hearing in this matter, held from February 25 to 27, 2004. Specifically, Midwest ISO sought confidential treatment for information it provided in response to a data request made by Commissioner Martin Huelsmann to Midwest ISO witness and Chief Financial Officer, Michael P. Holstein, regarding officer compensation for the years 2003 and 2004. In its petition, Midwest ISO informed the Commission that its compensation data for 2003 would remain confidential until it is reported on Form 1 to the Federal Energy Regulatory Commission ("FERC") on or before April 30, 2004, and that Midwest ISO's compensation data for 2004 would remain confidential until it is included in a similar FERC Form 1 filing on or before April 25, 2005. The Commission granted Midwest ISO's petition for confidential treatment of this information on March 15, 2004.

Pursuant to 807 KAR 5:001 § 7(9)(a), Midwest ISO hereby gives notice to the Commission that it publicly disclosed the compensation data for the year 2003 on Form 1, which it filed with the FERC on April 30, 2004. As such, the compensation data for 2003 may be

placed into the public record. Midwest ISO's compensation data for 2004 must remain confidential unless and until such data is disclosed in the FERC Form 1 filing on or before April 25, 2005. Midwest ISO notes, however, that the 2003 and 2004 compensation data were provided on a single-paged document with the information for which it sought confidential treatment highlighted pursuant to KAR 5:001 § 7(2)(b). The Commission thus cannot release that document into the public record without also disclosing the still-confidential 2004 compensation data. Therefore, Midwest ISO herewith submits to the Commission for filing in the public record, and serves upon the parties, a revised redacted version of Attachment B to its Response to the Commission's Hearing Data Requests, which Midwest ISO filed and served on March 8, 2004. This revised document discloses Midwest ISO's now-public 2003 officer compensation data; the redactions are of the 2004 compensation information.
